

Paragraph 16 of Last Will

This bequest has been carried out on the 26th day of January, 1937,  
and proceeds of sale given to Monsignor Philip Cullen by me.

I, Lucy M. Webster, being over the age of twenty-one years and of sound mind and memory, do hereby make, publish and declare this to be my last will and testament, and I hereby revoke any former will or codicil that I may have heretofore made:

I. I desire, as soon after my death as may be convenient, that my Executor herein named shall pay all debts that I may owe at the time of my death including taxes, expenses incident to my last illness and funeral expenses. I also direct that my Executor care for the expense incident to the placing on my tombstone of the inscription:

"Lucy M. Webster - Wife  
Year of birth - 1864  
(And also the date of my death)"

the same to correspond with the inscriptions already on the said tombstone in the space provided for the same. On August 21, 1935 a vault was provided in the lot for the reception of my remains.

II. I give and bequeath to my nephew, Edward H. Franelich the sum of \$500.00 and I hereby appoint his sister, Laura Odilia Franelich as his testamentary guardian to serve without bond.

III. I give and bequeath to my brother, Nicholas G. Franelich, the sum of \$2,000.00; to my sister, Mary T. Hurd, the sum of \$2,000.00; to my niece, Edwina C. Franelich, the sum of \$2,000.00; to my nephew Thomas Franelich the sum of \$2,000.00; to my nephew Henry K. Franelich the sum of \$2,000.00; to my niece Laura Odilia Franelich the sum of \$3,000.00; to my niece Amalie M. Ellis the sum of \$1,500.00; to my grand-niece, Aline McDuffie Cavanaugh, the sum of \$1,000.00; to my grand-nephew, Ralph F. McDuffie, the sum of \$500.00; to Margaret M. Krutter the sum of \$500.00; to my sister-in-law, Amelia M. Franelich, the sum of \$1,000.00; to Monsignor Philip Cullen the sum of \$500.00; to Sisters of St. Joseph in Mobile the sum of \$1,000.00; to Little Sisters of the Poor, for the Old Folks Home, the sum of \$500.00; and to my faithful servant, Martha Joseph, the sum of \$500.00

IV. I give and bequeath to my grand-niece, Louise M. Franelich, the sum of \$1,000.00, and I hereby appoint her father Henry K. Franelich as testamentary guardian to serve without bond.

V. I give and bequeath to my grand-nieces Blanche C. Ellis, Beatrice E. Ellis, Anna L. Ellis, Joyce Therese Franelich, Lucy G. Franelich, the sum of \$1,000.00 each, and I hereby appoint The Merchants National Bank of Mobile, a National Banking Association, as testamentary guardian of each of said children, to serve without bond.

VI. I give and bequeath to the Catholic Female Charitable Society, of Mobile, Alabama, the sum of \$2,000.00 - \$1,000.00 to be used for the benefit of orphan girls and \$1,000.00 to be used for the benefit of orphan boys.

VII. I give and bequeath to Monsignor Philip Cullen the sum of \$1,000.00, and request that masses be said for the repose of my soul.

VIII. I give and bequeath to the Right Reverend Thomas Toole, Bishop of Mobile, if he be then living, otherwise to the Bishop of Mobile for the Diocese, lots of land owned by me in the Ollinger and Stein Subdivision of Mandeville Tract and lot of land at Alabama Port, County of Mobile, Alabama.

IX. I give, devise and bequeath to my nephews Thomas Franelich and Henry K. Franelich, share and share alike, the real property owned by me at the Northwest corner of Beauregard and St. Joseph Streets, in the City of Mobile, Alabama.

X. I give, devise and bequeath to my niece, Edwina J. Franelich, the real property owned by me at the southeast corner of Beauregard and Joachim Streets in the City of Mobile, Alabama, and all personal property of every kind and description on said premises, including my automobile, except the specific bequests of jewelry set out in items herein of XVI and XIX, both inclusive.

XI. I give, devise and bequeath to my niece, Laura Odelia Franelich, the real property owned by me at 509 Charles Street, in the City of Mobile, Alabama.

XII. I give devise and bequeath to my faithful servant, Martha Joseph, the real property owned by me on Gorgas Street, in the City of Mobile, Alabama, for a home for herself.

XIII. I give and bequeath to my grand-nieces, Joyce Therese Franelich and Lucy C. Franelich, share and share alike, the \$4,000.00 mortgage made by Lena Lips to me on real property at the northwest corner of Beauregard and Conception Streets in the City of Mobile, Alabama.

XIV. I give and bequeath to my grand-niece, Louise M. Franelich, the \$3,000.00 mortgage due me on the Hietter property on Reed Avenue, in the City of Mobile, Alabama.

XV. I give and bequeath to Gertrude M. Poggi, the \$3,000.00 mortgage due me by Isabel U. Robertson on property situate at the northeast corner of Georgia and Carolina Avenues in the City of Mobile, Alabama.

XVI. I give and bequeath to Monsignor Philip Cullen as Pastor of St. Patrick's Church, in the City of Mobile, Alabama, my diamond stud and pair of earrings, and I hereby direct that this jewelry be sold and the proceeds used as a memorial to my beloved husband and myself.

XVII. I give and bequeath to my niece, Edwina J. Franelich, my diamond brooch.

AVIII. I give and bequeath to my niece Amalie M. Ellis, my ring with four diamonds and an emerald.

XIX. I give and bequeath to my niece, Laura Odilia Franelich, my ring of double cluster diamonds.

XX. All the rest and residue of my property, real, personal and mixed, I give, devise and bequeath in equal parts to Thomas Franelich, Henry K. Franelich, Edwina J. Franelich, Laura Odilia Franelich and Amalie M. Ellis.

XXI. I hereby nominate, constitute and appoint The Merchants National Bank of Mobile, a National Banking Association organized under the National Banking Laws of the United States, having its principal place of business in the city of Mobile, Alabama, as the sole Executor of this my last will and testament, and request that it be permitted to qualify as such Executor without giving bond as surety.

Should it become necessary to sell any of my real or personal property for the purpose of payment of my debts, costs of administration, or for the payment of specific legacies, then I hereby authorize my Executor herein named, to sell any portion of my real or personal property without any order of Court, and upon such terms as it may deem fit to impose; to convey the same whether by deed, bill of sale or otherwise, nor shall any purchaser be required to look to the application of the purchase price. I also authorize my Executor to rent, lease or sub-let any part of my estate; to collect all rents, profits, income, dividends, or issues due to same; to settle or compromise any claims owing either to me or by me to others; to do or cause to be done any and all things with relation to my estate that it may, in its discretion, deem proper.

I do request that my Executor shall employ as Attorney Joseph N. McAleer to protect this my last will and testament, and for such other purposes as may be required in the administration of my estate/<sup>up</sup>to and including the final settlement.
